CLINICIAN

We are very fortunate to have Alex Beaton coming to PEI to offer a cross-country jumping clinic June 14th & 15th at the Strathgartney Equestrian Park to all interested riders. Alex Beaton resides in Wilmot, Nova Scotia. Alex has an extensive Pony Club and Eventing background. She has achieved her Level 2 Equine Canada coach certification and her "A" level of proficiency with the Canadian Pony Club. She has also competed at the intermediate level and was long listed for the Canadian 3-day eventing team in the late '80s.

FORMAT

No previous Eventing experience is necessary, however, you and your horse/pony should be comfortable jumping cross rails and confident riding in an open field. The clinic will be two days. Saturday will be mainly Stadium with some Cross-country and Sunday will be just Cross-country. You may ride only Stadium or only Cross-country if desired.

This is an excellent clinic for all horse/rider levels, and especially so if you are not sure at what level you are ready to compete.

Riders will receive a 1½ hour group lesson each day. The information provided on the application form will be used to divide participants into groups of similar background and ability. Your group composition and ride times will be available Thursday evening June 12th, on our Facebook page, website, and from 6-9pm from Deborah Smith (902 620 1309). If you include an email on entry form, ride times will be emailed to you. It is your responsibility to know and be on time for your scheduled ride. **No refunds will be given after the 7th!**
Refunds will be given before the 7th with doctor/vet certificate only.
