Ruth Allum is the head coach and trainer at Oakhurst Farm. Ruth is committed to the total physical and mental preparation of both the rider and the horse. She combines her real life experiences as an Eventer with formal training as an Equestrian Canada certified High Performance – Eventing Coach. During her more than 20 years as a coach, Ruth has taken students from beginner levels to high levels of international competition. Whether her students are competing at the Pre-Entry or Advanced level, they still receive the benefit of Ruth's careful attention to detail in riding, conditioning, and building a strong horse and rider team.

Ruth has coached horse & rider teams to the Provincial Championships, the North American Young Rider Championships, the Canadian Eventing National Talent Squad as well as to a place on the Canadian Eventing Team Long List. She is also an Equine Canada Rider Level 1-10 Evaluator and an Equine Canada Rider Level Evaluator Mentor. Ruth is also an EC Certified Coach Developer – Evaluator for new coaches. Nationally, Ruth is proud to have been elected as Chair of the Canadian Eventing Committee and named to the Equestrian Canada National Coaching Technical Committee – representing Certified Equestrian – Eventing Coaches at the national level.

# FORMAT

No previous Eventing experience is necessary. Riders will receive a 1.5 hour group lesson Saturday and Sunday. Monday will be a schooling show with coaching given throughout by Ruth (optional). The information provided on the application form will be used to divide participants into groups of similar background and ability. No Refunds without Vet or Doctors note.

Preference will be given to riders enrolled in the IHC EAD Program.

#### Entries

Cheques must be dated for the due date (Wednesday, May 15<sup>th</sup>). Please make cheques payable to <u>Horse Trials PEI</u>. E-transfers can be sent to horsetrialspei@gmail.com

**Competitors must have PSO insurance (Island Horse Council/NSEF/NBEA etc)** Off-Island riders please send photocopies of your PSO and Horse Trials membership cards with your entry.

#### Fees

\$50/division for Horse Trials members, \$60 for non-members.

**IF entering Two Divisions, fees are:** \$80 for two divisions for members, \$100 for two divisions for non-members. **Late Fee:** \$20 late fee for entries received after Wednesday, May 15<sup>th</sup>.

### Prizes

Ribbons to 5th place. Classes will be split into Junior and Senior for placings if entries warrant.

#### Scratches and Refunds

In order to help us run our competition effectively, please be courteous and notify the show organizer **before** competition entry deadline if you must scratch. If you are unable to compete due to a horse's or rider's illness or injury, and have scratched as described above, entry fees will be refunded in full. Scratches after the entry deadline but 24 hours before show start, due to illness or injury will be refunded 50%. Scratches without 24hours notice to show organizers will not be refunded without doctor/vet note.

#### Dress

Show attire is recommended, but not mandatory. For new riders who may not yet have show attire, clean and neat attire will be accepted. In case of extreme weather (hot or rainy), adjustments may be made and competitors will be informed on the day of the show. Helmets and proper footwear (tall riding boots or paddock boots with chaps) are required. A safety vest is **required** for Cross-country phase.

#### **General Rules**

Protective headgear **must be worn** by any person when mounted anywhere on the show grounds.

Every division/test offered is covered by the rules and specifications of Equestrian Canada. Please be familiar with the rules, it is your responsibility to know the rules. Judge's decisions are final.

Competition numbers must be worn and visible in schooling rings and on the grounds as well as in the competition ring.

#### **Special Rules**

A horse/rider combination can compete in two consecutive Eventing divisions only. You may not enter the same division twice unless you ride two different horses in it. Two different riders may ride the same horse, but any horse cannot compete in more than two divisions per show. Test callers may be used if desired but must be arranged by the competitor. All tests will be ridden in 20 metre x 40 metre ring.

#### **Stadium Jumping Phase**

Listed heights are the *maximum* height that the course will be set to. Degree of course difficulty will be appropriate to the level. Note that these shows are meant to be a schooling type and courses will be set with this in mind.

#### Pace Phase (Optional)

Designed to help competitors learn and practice riding at the required speed or an intro for first timers to riding in the XC field. Riders will follow a set course around the cross-country field, keeping marker poles on their right. There are no jumps in this phase. Safety vests are required for this phase. Terrain: Rolling hills, open fields and wooded trails with excellent grass footing.

#### **Cross-country Phase**

This phase is designed to help competitors learn and practice their Cross country pacing skills along with jumping crosscountry jumps. You will be judged on your ability to complete the course closest to the optimum time. Time penalties will be given out as per normal XC rules to all divisions **EXCEPT PeeWee**, no time penalties for PeeWee. Safety vests are required for this phase. Terrain: Rolling hills, open fields, wooded trails with excellent grass footing. EV105 and Preliminary will be doing Training division jumps.

#### Format

Divisions will begin at PeeWee and go up to Prelim. Stadium phase will go next, followed by the Pace Phase (optional), and finishing with Cross-country. Depending on number of entries, entire divisions may finish before the next begins or they may overlap.

#### **Ride Times**

Ride times will be available Friday, May 17<sup>th</sup>, from the show organizer and will be posted on HTPEI's Facebook page and www.horsetrialspei.ca. It is your responsibility to find out your ride times and be on time for it.

#### Stabling

No onsite stabling. Competitors must arrange their own stabling. Contact organizer for stabling suggestions.
